Re: FY24 Facilities & Campus Services Maintenance & Operations Shop Rate Changes

Effective July 1, 2023 Facilities & Campus Services (FCS) will begin using new shop rates. The last time these rates were updated was July 1, 2019. As with the rest of the campus community, FCS has experienced considerable increases in personnel costs along with our commodity costs, and contractual service costs due to inflation and supply change challenges over the past four years driving this need for FCS to reevaluate the shop rates.

During this process, our team evaluated the method used to develop the rates. We considered four models and after evaluating the different methods and incorporating feedback from discussions with Vice Chancellor of Administrative Services Ryan Buchholdt, and primary stakeholders, FCS proposes to implement the rates developed using the Gordian RSMeans Facilities Maintenance & Repair Cost Data method effective July 1, 2023 and hold the rates for two fiscal years (FY24 & FY25) before proposing new changes.

We are committed to providing quality service to you and delivering Work Management, Building, Electrical, Mechanical and Custodial maintenance work along with Grounds, Horticultural, Fleet Maintenance and Transportation Services for our campus community to support a safe, modern, hi-tech, and welcoming environment and in alignment with our mission supporting student success.
