Re: Recommendation regarding changes to the IDEA system

After meeting twice and seeing a demonstration of the new platform for IDEA, the committee recommends signing a two to three year contract to adopt the new platform, hopefully rolling it out for use starting in summer 2019. Because time is short, there is not sufficient time to evaluate a new survey instrument now. The committee suggests trying to negotiate down to a two year contract, but believes a three year contract would be acceptable if pricing does not permit a shorter period. This will allow time for the faculty and administration to evaluate the new platform as well as other instruments, to determine what would be best for UAA in the longer term.

The new platform will have some advantages that we believe will improve the usefulness of IDEA for both faculty and access for students, such as:

- Surveys will be smartphone/tablet/desktop friendly.
- Surveys may be accessed via a single URL rather than a unique URL for each course
- Faculty may check response rates online.
- Custom questions may be added by college, department or course type (e.g., all online courses)
- Faculty may create mid-semester surveys with standard questions.
- IDEA reports may be accessed online within 48 hours of survey end.

In the adoption of the new platform, the committee recommends the following:

- All classes should be surveyed regardless of size. (Pricing allows for unlimited surveys and unlimited users.)
- Discussion is needed regarding which survey instrument will be the default for UAA, and whether faculty would be allowed to opt for other forms, especially in regards to requirements for promotion and tenure review files.
- Discussion is needed regarding the access to and distribution of qualitative data (i.e., comments).
